

BAIL BOND INFORMATION

We accept cash or bail bonds. Bail bonds need to be issued by a state approved bail bond agency. The personnel of San Bernardino County Sheriff's Department are prohibited from endorsing or recommending any specific bail bond agency.

Cash bails are processed at the Visiting Lobby of this facility. A posted cash bail must be the full amount of bail for each charge. A cashier's check, in lieu of cash, can be accepted. Checks must be payable to the agency designated by the facility.

VISITING INFORMATION

All **visits may be scheduled by phone**, 24 hours in advance, from 8:00AM to 5:30PM, Tuesday through Saturday. Inmates are allowed one (1) visit per day with a maximum of five (5) guests. **Visiting days** are Wednesday through Sunday from 8:30 AM to 9:00 PM. Visitors must arrive 30 minutes prior to their scheduled time. Late arrivals will not be admitted.

Inmates under special classifications may have a different set of visiting guidelines. Call information for inquiries. The visiting appointment line is (909) 887-0364. Inmates under disciplinary restrictions are not allowed visits.

ACCEPTABLE IDENTIFICATION

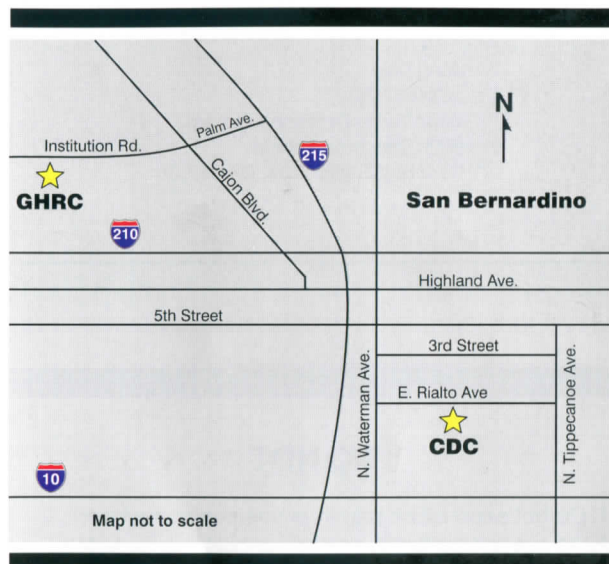

All inmate mail must have the following information printed on the outside of a plain white envelope.

DO NOT

1. Do not send blank paper, envelopes or stamps.
2. Do not put perfume, powder or cologne on letters.
3. Do not kiss inmate correspondence.
4. Do not send letters that are stained or extremely dirty.
Food items are not allowed.
5. Do not send more than ten photos (5x7 or smaller).
No frames or accessories will be accepted.
6. Do not send anything depicting violence, sex or gang affiliation.
7. Do not send nude/partially nude, photos/drawings,
8. Do not use whiteout, crayon or markers on inmate mail.
9. Do not send metal or plastic within inmate mail.
10. Do not send cards or letters with glue, tape, glitter, stickers or labels.
11. NOTE: All books and magazines must come directly from the publisher, must be paperback and all business labels must be printed. Hand written labels will not be accepted.

INMATE MONEY

We accept **Cashier's Checks** and **Money Orders**. Cashier's Checks or Money Orders should be made payable to the West Valley Detention Center with the name and booking number of the inmate included on the check/order

No personal checks will be accepted

Cash deposits are processed at the Fiscal Office located in the Visiting Lobby of this facility. Deposit slips must be completed to be enclosed with the exact amount of money. The Fiscal Office is open to the public from **8:00 AM to 10:00 PM, seven (7) days a week**

The department maintains individual accounts for each inmate in which deposits and withdrawals are posted. Upon release from custody, the inmate will be paid his/her account balance by check, cash or a combination of both. Checks issued by the facility can be cashed at any branch of Citizens Business Bank or any check-cashing place.

Visitors are prohibited from wearing the following:

- Gang attire.
- Hats.
- Clothing or accessories displaying obscene or offensive language or pictures.
- Sheer or transparent garments.
- Tank tops, halter tops, strapless or spaghetti strap tops.
- Clothing exposing the breast/chest, midriff area, genital area or buttocks.
- Shorts, skirts and dress shorter than mid-thigh.
- Clothing revealing underwear
- Shoes shall be worn
